



Furcation 2026 Conditions of Sale

1. Conditions of entrance

- 1.1. You are only able to purchase tickets for Furcation 2026 via our registration system on reg.furcation.org.uk. Furcation LTD does not outsource its ticket sales to any third-party providers.
- 1.2. If you have not purchased or been allocated your attendance ticket from our registration system, it is not a valid ticket.
- 1.3. A ticket purchased on your account is for your sole use only. You are not permitted to resell your accommodation or entry ticket to anybody else (See 2.4 for Transfers)
- 1.4. Furcation LTD reserves the right to cancel any tickets that appear to have been resold without prior notification and the holder will be refused entry.
- 1.5. John Fowler Holidays (Our hosts) will also reserve the right to refuse access to accommodation for anyone who has not been named on the attendance list shared with them.
- 1.6. If you need to transfer your ticket, this must be done only by contacting our registration team through support.furcation.org.uk
- 1.7. Please do not attempt to contact our registration team by any other means unless specifically directed to do so by them.
- 1.8. If you wish to change the Guests within your accommodation, our registration team will accept up to three separate instances of change. Additional changes beyond that are at the discretion of the registration team.
- 1.9. If you are allocated accommodation as a group lead, your attendance is bound to the accommodation offered. Cancelling accommodation post-lottery will be treated as a request to cancel your ticket.
 - 1.9.1. If this occurs, you will be required to nominate someone within the allocated group to take ownership of the booking.
- 1.10. To enter the Furcation event or on-site accommodation, you will be required to provide one Government-standard photographic proof of identification to prove your identity and to confirm that you are over the age of 18

NO ID = NO ENTRY

Accepted forms of ID: UK/International Driving Licence, UK/International Passport, UK 'PASS' certified ID card, NPASS, Post Office, MyIDCard International government ID card, UK Armed Forces/Veteran ID card

2. Cancellations, delays, refunds and exchanges

- 2.1. If you need to cancel your attendance to Furcation, this must be done by raising a support ticket through support.furcation.org.uk using the 'registration enquiry' option.
- 2.2. As we need to pay our venue for the accommodation and our suppliers for the event, we can only offer a refund during your statutory 14-day window from the date of payment, excluding exceptional circumstances.
- 2.3. If you are removed from the premises by John Fowler's Security for breaching venue regulations or removed for breaching the Furcation Code of Conduct, no refund will be issued.
- 2.4. If you wish to transfer your attendance ticket to somebody else, this must be requested no later than 25th October. We will not accept changes after this date.
- 2.5. If the cancellation or delay to the event has been invoked by either John Fowler Holidays or Furcation LTD, a communication will be issued to all attendees detailing the reasons for the cancellation and details of any refund that will be issued. In these circumstances, John Fowler Holidays or Furcation LTD would only be liable for the refund of any dues paid to them for the event. We would not be liable or able to assist with any refunds for transportation tickets or any other expenses incurred.
- 2.6. It is your responsibility to ascertain whether an event has been cancelled or re-scheduled and the date and time of any re-scheduled event. Where an event is cancelled or re-scheduled, we will use our reasonable endeavours to notify you using the details you provided us with at the time of ordering. We do not guarantee that you will be informed of such cancellation before the date of the event.
- 2.7. It is your responsibility to inform us of any change to the contact details or registered email address you provide us with at the time of registration.
 - 2.7.1. We may use your email address to reach out to you and your group with queries about your booking.
- 2.8. Furcation LTD or John Fowler Holidays are unable to bear any liability for an attendee unable to attend the event due to infrastructure failures (transportation, rail strikes). If you are unable to attend due to these circumstances, we will be unable to offer a refund and would advise you seek compensation via your Travel Provider or your Travel Insurance.

- 2.9. If either John Fowler Holidays or Furcation LTD are forced to abandon the event over the course of the weekend due to:
- Severe weather that poses a threat to life
 - Force Majeure
 - A large scale incident such as a fire at the venue or death of an attendee.
 - Any other scenario that means shutting down the event is in the best interests of safety of the attendees

Neither John Fowler Holidays nor Furcation LTD will bear any liability for the early abandonment and no refunds will be permitted.

3. Liability

- 3.2. Nothing in these Terms and Conditions seeks to exclude or limit either Furcation LTD or John Fowler Holidays liability for death or personal injury caused by negligence, fraud or other type of liability which cannot by law be excluded or limited.

4. General

- 4.1. Furcation LTD and John Fowler Holidays may carry out film or sound recording in or around our venue. By purchasing a ticket to the event, you consent to you being included in any recording and to its exploitation without payment.
